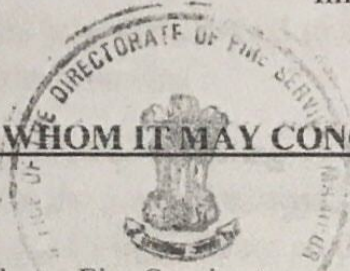

This is to certify that a Fire Service team under the supervision of the undersigned have inspected "THE THOKCHOM IBOTOMBI INSTITUTE OF TEACHER EDUCATION AND TRAINING", located at Bishnupur District, Manipur having facilities from Class I to Class XII on 20.03.2013 to assess the feasibility of Fire risk inside the School campus and no visible sign of high Fire risk can be seen in and around the School building during the course of inspection. The School building is surrounded by paddy field on the northern, eastern and western sides and approach road (Khoijuman road) on the southern side. All Class Room of the School buildings are provided sufficient doors/exits and no problem being faced for quick evacuation of students at any emergency. One Thonjao lok (River) is there on the southern side which can be used in case of Fire Fighting purposes at any time.

**Fire Fighting Equipments available** :- The following types and quantities of First Aid Fire Fighting equipments are found installed at proper locations of the School buildings in good working conditions and the teaching and non-teaching staffs are also imparted training on used, care, handling and maintenance of the same :

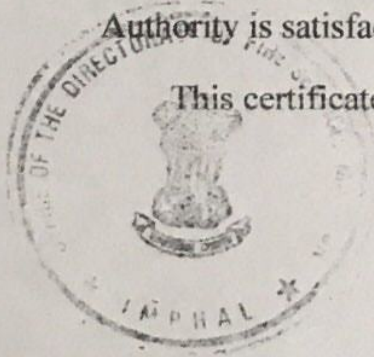


In addition to above, it is also advised to the School Authority for taking follow-up action to the following :

1. Maintenance/Checking/Testing of all Fire safety installations in the School be carried out from time to time.
2. Water sources of Fire Fighting purposes should be available in the School premises throughout the year.
3. All EXITS provided in the School building be kept free from any obstruction.
4. Fire Fighting training & mock drill exercise be organised quarterly/half yearly with intimation to Fire Service Department.
5. Kitchen/Residential building/structure be separated from the School building/away from the Classrooms.
6. First Aid Kits and necessary medicines are readily available in the School.
7. Fire/Emergency Telephone numbers be displayed on the Notice Board.
8. Fire Safety Day be observed in every year on 14<sup>th</sup> April with awareness programme.
9. School building be insured against fire and natural calamities with group insurance of School Pupils


Hence, the Fire Precautionary measures taken-up by the School Authority is satisfactory subject to the above conditions.
